WE ENROLLED 120 INDIVIDUALS WHO SOUGHT OUR ASSISTANCE FOR THE FIRST TIME. DURING THESE SIX MONTHS THERE WERE JUST UNDER 4.000 INDIVIDUAL VISITS TO OUR PANTRY.

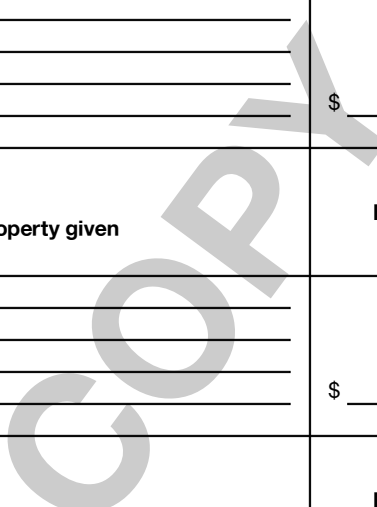
